

Rules of Play – The Starlight Insurance Campaign November 2024 Calendar Raffle Charitable Registration Number: 13129 5693 RR0001

Eligibility

Starlight Children's Foundation Canada employees and their immediate family members (spouses, parents, children, siblings, and their respective spouses, regardless of where they live) or persons living in the same households of such employees, whether or not related, are not eligible to enter the draw.

Participants must be at least 18 years of age and a Canadian resident. Tickets cannot be purchased in the name of a minor. Only tickets that have been paid for and/or have been verified as paid for are eligible to be entered for the Calendar Raffle draw(s).

Ticket Deadlines and Draw Dates

Tickets are \$30 each at www.starlightinsurancecampaign.org/calendar-raffle. You will receive a confirmation email after your donation has been processed. Official tickets, along with the Rules of Play, will be delivered to the customer via email within 3 business days from time of purchase.

The official Calendar is a receipt of purchase. It is the responsibility of the ticket holder to ensure that they receive their ticket(s). Ticket purchases are not tax-deductible. No refunds will be issued after purchase.

Draws will be conducted daily from November 1st to November 30th, 2024. In order to be eligible for the chance to win each and all prizes, tickets must be purchased before 11:59 PM (EST) on October 31st, 2024. Tickets purchased through the month of November will only be entered into the draw starting the following business day from time of purchase.

The holder of the ticket number drawn will win the prize designated for that day as described on the Calendar. Your unique ticket number can be found in red text on the bottom left of your calendar.

Special Promotion: On October 16th, 2024, a one-time offer of buy 3, get 5 Calendar Raffle Tickets will be available. Promotion date subject to change.

Chances of Winning

Chances of winning are 1 in 3,000 or greater. Final odds are dependent upon the number of tickets sold (up to a maximum of 3,000).

There are 30 prizes to be awarded valued at a minimum of \$250.
